1. Scope of Work:

The scope covers supply, installation, testing & commissioning of IP Based CCTV Surveillance system as per given specifications, Documents (Manuals) & Training, and safe delivery to the point of installation. The scope of the work includes:

AI Software, Analytics – (Detection should be based on both AI & Satellite for Fire Management, Risk Index, Weather Data; Fire Propagation

Component 2

One Time Hardware for AI Cameras
AI Detection Camera, Installation on Site, Autonomous Solar Power,
Communication to Control Room, Maintenance & Upgrade

Component 3

Control Room Setup
Receiving Station for Towers installed, Designated Control Room. Includes
Displays, Touch and Onscreen, Processing Computers, Storage, Recording
and Monitoring, Siren Systems, Firewalls, Bandwidth, Routers.

Component 4

Installation of Towers
On Site Civil Erection of GBT Tower (Ground Based Tower) with Foundation (so as to cover the entire sanctuary area) – 45 metres to sustain Wind Velocities up to 100 km, Transport to Remote Sites, 1 Year Maintenance.

2. Detail Terms and Condition:

Detailed Terms and Condition for Tender for Supply, Installation, Testing and Commissioning of tower based AI detection and Forest Fire Warning Solutions" in Similipal Wildlife Sanctuary are as under:

A. Technical Bid

2.1The bidder should give the precise location (GPS readings) of the towers and cameras so that the entire Sanctuary area is covered. The specifications of the cameras and the warranty of all the hardware are to be indicated.

2.2The AI algorithms shall be designed in such a way that it will detect the fire automatically and gives instant alert to the control room and the users

registered mobile number on real time basis.

2.3The cameras shall able to rotate 360 degree and detect any forest fire or poachers movement or wildlife activity as desired by the authority.

- 2.4The system shall be integrated with real time satellite data on weather, forest fire and deforestation to provide a real time alert and also to empower to provide early warning through AI based continuous analysis. Bidder should indicate the satellites used for this purpose and also the time lag for receiving the alerts.
- 2.5 The system should have complete flexibility for upgrading and expansion in all respects depending on future requirements. The system should have liberty to add additional module in future based on the requirement. The system should support additional modules like Propagation model, Carbon Analysis, Deforestation basic, bioacoustics, third party integration etc. to be integrated in future as per demand.
- 2.6 The bidder should indicate the additional module separately which can be integrated in to the system in later stage as per demand clearly in the technical bid an also indicative price of the same in the financial bidding.
- 2.7 The Authority reserve the right to accept or deny the proposal for additional modules at any point of time without assigning any reason thereof.
- 2.8 Technical bid should contain technical details provided along with relevant supporting Documents attached such as technical specifications, technical compliance, and data sheets.
- 2.9 The System shall be accepted based on the test certificates submitted by the manufacturer/bidder and successful completion of all the components as an integrated system after Installation & Commissioning at the installation site. Not meeting any of the component specifications will lead to rejection of the system as a whole.
- 2.10 Minimum one years on site comprehensive warranty is required for the whole project /system from the date of final handing over the system to Authority. Tenderer will have to quote for extended on site comprehensive warranty for total Forest Fire warning system expiry of warranty period. However, the contract for extended warranty period will be awarded, if required.
- 2.11 Routine servicing/ troubleshooting/ setting/ adjustments etc., periodically in every 3 month, to ensure smooth and trouble free working of each camera, other components and the system as a whole during comprehensive warranty.

B. Financial Bid

2.12 Financial bid(s) of the only technically qualified tenderer(s) will be opened for financial evaluation. Prices should be inclusive of all Taxes & Duties, as applicable. The financial bid(s) will be evaluated on the basis of the total cost as quoted.

2.13 Financial bid will be opened day after the technical bidding date i.e. 29.02.24 at 11.00 A.M in the office of the Deputy Director, Similipal South Wildlife Division, Baripada in presence of the bidder or their representative.

C. General Term & Condition

- 2.14 The bidders who wish to supply the system shall produce the Test/ Qualification Certifications of the cameras. Bidding without certificates or producing fake certificates may lead to disqualify the bidder.
- 2.15 The complete hardware and software support to be extended by the contractor.
- 2.16 Diagnostic checks shall be done by the system periodically for the proper functioning of the Video Cameras.
- 2.17All pre-bid queries have to be submitted in writing to Deputy Director, Similipal official email Baripada through Division, Wildlife dfo.similipalsouthwl@odisha.gov.in on or before 10.03.24 by 02:00 PM in the South format given below on the letter head of the company.

No queries will be entertained after this allotted time frame. If it is considered necessary to modify the Technical Specifications or any Tender conditions, the same shall be carried out. The modified tender documents will again be uploaded on the website www.similipal.org for the information of all prospective tenderers.

- 2.18 All the pages of the Technical / Financial Bid format shall be page numbered and all the relevant supporting documents as required must be enclosed along with tender.
 - 2.19The approved vendor has to quote considering the location of the cameras installation site and other accessories necessary for successful design, supply, installation, testing and commissioning of AI based forest fire warning system. The accessories should include but not limited to the indicated here. The accessories are indicative and it is intended to install the system in successful manner. Attached Annexure for Bill of quantity is an indicative list of items that may be used for successful installation. Please Note that the complete package of AI based forest fire warning system including towers and other items mentioned in BOQ may be increased or decreased. The payment will be made as per actual basis.

- 2.20 Payment Terms: 30% payment of the order value shall be released after the receipt of material in good condition at the installation site after inspection in phase wise manner. 60% of the order value shall be released after satisfactory installation / commissioning and handover of the equipment's in faultless working condition for period of 90 days from the date of satisfactory installation and submission of the test report. Balance 10% of the order value shall be released after 180 days after satisfactory installation and submission of the test report. No advance payment will be made under any circumstances.
- 2.21 The work should be carried out in close coordination with the authority, field staffs and with minimum disturbance to the wildlife and its habitat. No works shall be executed after sunset and before sunrise in the sanctuary area. The workers shall strictly abide the provision of the Wildlife Protection Act, 1972 or any relevant act time being in force. Any violation of the above provision will be viewed seriously may leads to rescindment of the entire contract.
- 2.22The system should confirm highest standards of the engineering design and workmanship. The system should perform well without much degradation for the service life of 5 years from the date of completion of Job.

- 2.24 Bidder/Firm has to clean all the debris left behind after work at the end of days. They shall be responsible for labour engaged for their code of conduct.
- 2.25 Laying fiber/ cabling/ pipe etc. is under this contract/ scope of work and route is subject to approval of the competent authority. All works involved at Site grading, excavation in the soft soil, soft or hard murum, and back filling will be done with prior approval from the competent authority.
- 2.26 The work shall be completed within the end of FY 2023-24 i.e. $31^{\rm st}$ March 2024 in all respect. Party has to submit the detailed time schedule for execution of the work after issue of Work Order.
- 2.27 Quotation should be valid till 180 days from the date of opening of financial bid.
- 2.28 Termination for Default: The 'Authority' may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Bidder, terminate the Contract in whole or in part: If the Bidder fails to deliver any or all of the Goods within the period(s) specified in the Contract, or within any extension thereof granted by the Purchaser; or If the Bidder fails to perform any other obligation(s) under the Contract. If the Bidder, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract. For the purpose of this clause: "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement

- specified by the Institute. After the award of the contract to the successful tenderer, the Earnest Money Deposit (EMD) of all the unsuccessful tenderer(s) will be refunded within 30 days.
- 2.31 Performance Security PBG (3% of the contract value) should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the Bidder including warranty obligations. The same will be released only after expiration of the validity. The bank guarantee is to be given as per the format attached with this Tender. The successful contractor has to sign an agreement within 7 days from the date of issue of work order on the stamp paper of appropriate value as per format given herein.
- 2.32The incomplete and conditional tenders will be rejected. Quoting of unrealistic rates will also be treated as disqualification.
- 2.33 Bidder shall not be permitted to withdraw his/her offer or modify the terms and conditions thereof after acceptance of tender. In case the Bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rate, the aforesaid amount of Earnest Money Deposit and Performance Guarantee will be forfeited by the 'Authority'. Besides this, the Bidder will also be liable to be debarred/blacklisted from participating in the tendering process of the 'Authority' in future and/or suitable penalty will be levied.
- 2.34 Normally no extensions of the scheduled delivery or completion dates should be granted except where events constituting force majeure, as provided in the contract, have occurred or the other circumstances demands for.
- 2.35 All the applicable taxes are to be paid by the Bidder/Firm. Price should be quoted accordingly. No price variation shall be allowed during the contract.
- 2.36On receipt of intimation from the 'Authority' of the acceptance of his/their Tender, the successful Tenderer shall be bound to implement the contract and within 7 days thereof, the successful Tenderer shall sign an agreement and the Schedule of terms and conditions but the written acceptance by the 'Authority' of a tender will constitute a binding contract between the 'Authority' and the person so Tendering whether such formal agreement is or not subsequently executed.
- 2.37 Minimum one week Training Programme needs to be scheduled/arranged by the successful bidder, without any additional extra charges. The supplier shall provide training at Deputy Director, Similipal South Wildlife Division, Baripada office premises for personnel of user department on the operation, maintenance of the project 'Tower based AI detection & forest fire warning solution system'. Training manuals [5 copies] towards this should be prepared and handed over to the user department before starting of the training.

2.38 Guarantee/Warranty Duly signed and stamped certificate of at least 2 years comprehensive onsite warranty as per Annexure-B should be attached with the technical bid. Successful firm will be required to agree for payment of

"fraudulent practice" means a process or in contract execution. misrepresentation of facts in order to influence a procurement process or the execution or a contract to the detriment of the borrower and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the borrower of the benefits of free and open competition. In the event the Purchaser terminates the Contract in whole or in part, the Purchaser may procure, upon such terms and in such manner as it deems appropriate, Goods or services similar to those undelivered, and the Bidder shall be liable to the Purchaser for any excess costs for such similar Goods or services. However, the Bidder shall continue the performance of the Contract to the extent not terminated. The contractor/bidder shall not display the photographs & content of the work and also will not take advantage through publicity of the work without written permission of the Authority. Non-Compliance to this may result in the blacklisted of firm. The incomplete and conditional tender will be rejected. Quoting unrealistic rates will also be treated as a disqualification.

- 2.29 Force Majeure: In no event shall either Party have any liability for failure to comply with this Agreement, if such failure results directly from the occurrence of any contingency beyond the reasonable control of the Party, including, without limitation, strike or other labour disturbance, riot, major power failure, war, natural calamities including but not limited to floods, earthquakes, fire, volcanic eruptions, epidemics, National Emergency, interference by any government or governmental agency, embargo, seizure, or enactment or abolition of any law, statute, ordinance, rule, or regulation (each a " Force Majeure Event"). In the event that either Party is unable to perform any of its obligations under this Agreement because of a Force Majeure Event, the Party who has been so affected shall as soon as may be, after coming to know of the Force Majeure Event, inform the other Party and shall take reasonable steps to resume performance as soon as may be after the cessation of the Force Majeure Event. If the period of non-performance due to a Force Majeure Event exceeds thirty (30) days, the Party whose ability to perform has been so affected may, by giving written notice, terminate this Agreement.
- 2.30 The bidder has to submit the non-refundable tender paper cost of Rs. 10,000/(Rupees Ten Thousand only) and earnest money deposit of Rs. 2,00,000/(Rupees Two lakh only) which is refundable by way of demand draft only. The demand draft shall be drawn in favour of "The Deputy Director, Similipal South WL Division, Baripada" payable at Baripada. The demand draft for earnest money deposit must be with the technical bid. Any Technical-Bid found without the Earnest Money Deposit (EMD) will be rejected. The Authority will not be liable to pay any interest on such an amount. The Earnest Money Deposit (EMD) shall be forfeited, if the tenderer withdraws its bid during the period of tender validity. The Earnest Money Deposit (EMD) of the tenderer, whose tender has been accepted, will be returned on the submission of the Performance Security. Earnest Money Deposit (EMD) of the successful tenderer shall be forfeited, if it refuses or neglects to execute the order or fails to furnish the required performance security within the time frame as

- penalty for exceeding permissible downtime during Guarantee / Warranty period.
- 2.39 The material found defective upon opening by the supplier representative in presence of technical committee as constituted by the 'Authority' or not as per tendered specifications will be lifted back at the cost and risk of the supplier from the delivery site.

2 40 Arbitration

- a. In the event of failure to carry out the contractual obligations, with in the stipulated period or extended period and determination of the contract for any reason. Violation of the warranties etc. the 'Authority' shall have the right to carry out the unfinished obligation at the exclusive cost and risk of the bidder/firm, after due notice and the difference so accrued shall be recoverable from the bidder/firm.
- b. The provision of the Arbitration and conciliation Act, 1996 or as at relevant time and of rules framed there under and any statutory modifications thereof shall be deemed to apply and be incorporated in this agreement.
- c. Upon every or any such reference, the cost of any incidentals to the reference and award(s) respectively shall be at the reasonable discretion of the Arbitrators or in the event of their not agreeing, of the Umpire appointed the amount thereof or direct the same to be fixed as between solicitors and client or as between parties and shall be direct by whom and in what manner the same shall be borne and paid.
- d. Panel of arbitrators will be provided by the 'Authority' out of which the bidder will have to select one.
- e. The bidder shall have no objection if the officer who has dealt with the case at any stage is nominated as an arbitrator. Further, that one of the arbitrator's shall be Accounts Expert.
- f. In case of vacancy being caused due to resignation, death or incapacity of the arbitrator's to function as such, the same shall be provided in the aforesaid manner and the new arbitrator's shall proceed from the stage at which vacancy is caused.
- 2.41 All disputes shall be subject to the jurisdiction of the Court of Law at Baripada, Mayurbhanj, Odisha

3. Pre-qualification Criteria for Eligible Bidders:

Any false and/or inadequate information can result in rejection of the tender. While deciding on the selection of contractors, emphasis will be given on the ability and competence of applicants to do good quality works in the specified time schedule and in close co-ordination with other agencies. Decision of the 'Authority' with regard to selection of contractors will be final. The 'Authority' is not bound to assign any reasons thereof. The following are the criteria:

The bidder shall have minimum 3 years of experience in the field of supply & installation of early warning system.

- The bidder must be an OEM or registered dealer of the product they are intended to supply. In both of the cases the certificate to that effect to be furnished by the bidder.
- The bidder shall have valid clients in India which it has served at least during last iii.
- iv. The bidder shall have served to any Government department or Forest Department in any States of India during last 3 years. The bidder shall have to produce an authenticate certificate to his effect during participation in the bidding or else the bidding will be summarily rejected.
- The bidder shall have registered office in India. The certificate to this effect should be submitted.

However, preference will be given to the bidder in selection during technical bidding if the bidder have the following criteria;

- i. The bidder shall have minimum Installed 100+Towers for Early Warning Systems across worldwide/India is working satisfactorily. The bidder has to produce a valid certificate to this extent issued from the client.
- ii. The bidder or firm must have over 10 Million Hectares area covered in Client Projects-India / Worldwide.
- iii. The bidder/firm at least have covered over 1 Million Hectare of Forest Area across globe/India under this project in installation.
- iv. The Software should have integration with Forest Systems.

4. Method of Selection

- i. The tender shall be prepared and submitted in two parts, viz, Part-I containing Technical and Commercial details of the offer and consent of the Contractor for terms and conditions of the tender and Part-II containing Prices only (Financial Bid).
- ii. Telegraphic, Fax and E mail tenders will not be accepted.
- ii. Insertions, post scripts, additions and alterations shall not be valid unless confirmed by the tenderers signature. All copies of the tenders should be completed in all respects with all attachments/enclosures/annexures.
- iii. The Authority will evaluate the tenders, strictly on the basis of the terms & conditions incorporated in the tender document with the terms & conditions etc. as stipulated by the tenderer(s) in their tender to determine whether these are compliance in all respects, as specified in the tender document.
- iv. During the evaluation / scrutiny of the tenders, at any stage, if it is found that any of the tenderer(s) terms and conditions are not compliance with tender document, 'Authority' may seek the clarification within the specified target time and if the tenderer fails to reply / or not agree / accept the terms & conditions, their tender will be treated as unresponsive and it is liable for
- v. Evaluation of the proposals shall be done in two stages as: Technical-Bid/ Evaluation and Financial-Bid/ Evaluation. Technical evaluation of the proposals

shall be done on the basis of essential pre-qualification criteria and the required Technical Specification. The Financial-Bid of the only technically qualified

tenderer(s) will be opened on fixed date and time.

vi. A technical committee will be constituted by the authority to scrutinise the bidding documents as per the technical requirement specified in this tender or part of tender documents. The technical committee will verify the technical specification of the hardware, software as proposed by the participating bidder and select the best with and latest available hardware and software in this segment which will meet the requirement. The decision of the committee will be final and binding upon the parties.
