

2. SCOPE OF WORK

The scope of work covers supply, installation, testing & commissioning of tower mounted high resolution surveillance cameras as per given specifications, Documents (Manuals) & Training, and safe delivery to the point of installation with real time alert system. The works will be executed in various forest blocks of **Similipal South WL, Baripada(T), Balasore WL, Rairangpur (T), Karanjia(T) & Keonjhar WL** divisions under Baripada circle for active detection of Forest fire, detection of movement of wild animals, detection of poacher movement and for use in other wildlife related management.

The entire works is splitted into 2 categories. The first(1st) category involves detection of Forest fire through 360° rotations AI camera with real time transmission to control room for active fire management. The second category involves AI based detection of the movement of wild animal with real time transmission to control room from both network and no network area to prevent depredation, road railway accidents etc. The scope of the work includes:

Scope-A

Component-1

AI Software, Analytics –

(Detection should be based on both AI & Satellite for Fire Management, Risk Index, Weather Data; Fire Propagation etc. In addition to that AI based detection of wild animals to the extent of identifying species and location and distance)

Component 2

One Time Hardware for AI Cameras

(AI Detection Camera, Installation on Site, Autonomous Solar Power, Communication to Control Room, Maintenance & Upgrade.)

Component 3

Control Room Setup


Receiving Station for Towers installed, Designated Control Room. Includes Displays, Touch and Onscreen, Processing Computers, Storage, Recording and Monitoring, Siren Systems, Firewalls, Bandwidth, Routers.

Scope-B

Component 4

Installation of Towers

On Site Civil Erection of GBT Tower (Ground Based Tower) with Foundation (so as to cover the sensitive and vulnerable locations with respect to Forest fire and wild animal movement) – height up to 45 metres (depending upon objective and purpose) to sustain Wind Velocities up to 100 km, Transport to Remote Sites, 1 Year Maintenance.

3. INSTRUCTIONS TO THE BIDDERS

- a. The Deputy Director, Similipal South Wildlife Division hereinafter called as "Authority" invites sealed proposals from eligible bidders for **"Supply, Installation, Testing and Commissioning of Tower mounted AI camera for detection of Forest Fire & AI based surveillance on wild animal Movement with Real time Alert System"** in various Forest & Wildlife divisions under Baripada Circle, Odisha as per detailed scope of work in this RFP document.
- b. This invitation to bid is open to all bidders meeting the minimum eligibility criteria as mentioned in this tender Document.
- c. Not more than one bid shall be submitted by one Bidder.
- d. Proposals must be received not later than time, date and venue mentioned in the Fact Sheet. Proposals that are received late will not be considered in this procurement process.
- e. Bidder who has downloaded the tender document from the official website: (www.similipal.org) shall not tamper/modify the RFP form including downloaded price bid template in any manner. In case if the same is found to be tampered /modified in any manner, bid will be completely rejected and EMD would be forfeited and Bidder is liable to be banned from doing business with the authority.
- f. The authority will award the contract to the successful bidder whose proposal has been determined as the best value proposal based on Technical and Financial evaluation criteria and accepted by the Tender Accepting Authority.
- g. The authority reserves the right to reject any or all the Bids in whole or part, prior to signing of the Contract, without assigning any reasons.

3.1 General Instructions

- a. All information supplied by Bidders may be treated as contractually binding on the Bidders, on successful award of the assignment by the "Authority" on the basis of this tender.
- b. No commitment of any kind, contractual or otherwise shall exist unless and until a formal written contract has been executed by or on behalf of the "Authority". Any notification of preferred Bidder status by the "Authority" shall not give rise to any enforceable rights by the Bidder. The "Authority" may cancel this public procurement at any time prior to a formal written contract being executed by or on behalf of the "Authority".
- c. This tender supersedes and replaces any previous public documentation and communications, and Bidders should place no reliance and dependence on such communications.

- a. Bidders are advised to study all instructions, forms, terms, requirements and other information in the tender documents carefully. Submission of the bid shall be deemed to have been done after careful study and examination of the bid document with full understanding of its implications.
- b. Failure to comply with the requirements of this paragraph may render the Proposal non-compliant and the Proposal may be rejected. Bidders must:
 - Include all documentation specified in this tender.
 - Follow the format of this tender and respond to each element in the order as set out in this tender.
 - Comply with all requirements as set out within this tender document.

4. DETAIL TERMS AND CONDITIONS

Detailed Terms and Condition for Tender for "**Supply, Installation, Testing and Commissioning of Tower mounted AI camera for detection of Forest Fire & AI based surveillance on wild animal Movement with Real time Alert System**" in various Forest & Wildlife divisions under Baripada Circle, Odisha are as under;

A. Technical Bid

- 4.1 The bidder should give the precise location (GPS readings) of the towers and cameras so that the desired area of surveillance is covered. The bidder shall finalize these locations in consultation with the authority and is subjected to approval of the authority.
- 4.2 The specifications of the cameras and the warranty of all the hardware are to be indicated.
- 4.3 The AI algorithms shall be designed in such a way that it will detect the forest fire and also the wild animal movement automatically and gives instant alert to the control room and the users registered mobile number on real time basis.
- 4.4 The camera shall provide continuous feed of information on 24x7 basis. In the event of wild animal detection, the AI camera shall be trained to the extent to identify the species, it's exact location with GPS etc.
- 4.5 The cameras shall able to rotate 360° and detect any forest fire or animal movement or wildlife activity as desired by the authority.
- 4.6 In case of Forest fire, the system shall be integrated with real time satellite data on weather, forest fire and deforestation to provide a real time alert and also to empower to provide early warning through AI based continuous analysis. Bidder should indicate the satellites used for this purpose and also the time lag for receiving the alerts.
- 4.7 The system should have complete flexibility for upgrading and expansion in all respects depending on future requirements. The system should have liberty to add additional module in future based on the requirement. The system should support additional modules like Propagation model, Carbon

- Analysis, Deforestation basic, bioacoustics, third party integration etc. to be integrated in future as per demand.
- 4.8 The bidder should indicate the additional module separately which can be integrated in to the system in later stage as per demand clearly in the technical bid an also indicative price of the same in the financial bidding.
- 4.9 The Authority reserve the right to accept or deny the proposal for additional modules at any point of time without assigning any reason thereof.
- 4.10 Technical bid should contain technical details provided along with relevant supporting Documents attached such as technical specifications, technical compliance, and data sheets.
- 4.11 The System shall be accepted based on the test certificates submitted by the manufacturer/bidder and successful completion of all the components as an integrated system after Installation & Commissioning at the installation site. Not meeting any of the component specifications will lead to rejection of the system as a whole.
- 4.12 Minimum one years on site comprehensive warranty is required for the whole project /system from the date of final handing over the system to Authority. Tenderer will have to quote for extended on site comprehensive warranty for total Forest Fire warning system expiry of warranty period. However, the contract for extended warranty period will be awarded, if required.
- 4.13 Routine servicing/ troubleshooting/ setting/ adjustments etc., periodically in every 3 months, to ensure smooth and trouble free working of each camera, other components and the system as a whole during comprehensive warranty.

B. Financial Bid

- 4.14 Financial bid(s) of the only technically qualified tenderer(s) will be opened for financial evaluation. Prices should be inclusive of all Taxes & Duties, as applicable. The financial bid(s) will be evaluated on the basis of the total cost as quoted.
- 4.15 Financial bid will be opened day after the technical bidding date i.e. 29.10.2024 at 11.00 A.M onwards in the office of the Deputy Director, Similipal South Wildlife Division, Baripada in presence of the bidder or their representative.

C. General Term & Condition

- 4.16 The bidders who wish to supply the system shall produce the Test/ Qualification Certifications of the cameras. Bidding without certificates or producing fake certificates may lead to disqualify the bidder.
- 4.17 The complete hardware and software support to be extended by the contractor.
- 4.18 Diagnostic checks shall be done by the system periodically for the proper functioning of the Video Cameras.
- 4.19 All pre-bid queries have to be submitted in writing to Deputy Director, Similipal South Wildlife Division, Baripada through official email id: dfo.similipalsouthwl@odisha.gov.in on or before 28.10.2024 by 04:00 PM in the format given below on the letter head of the company.

No queries will be entertained after this allotted time frame. If it is considered necessary to modify the Technical Specifications or any Tender conditions, the same shall be carried out. The modified tender documents will again be uploaded on the website www.similipal.org for the information of all prospective tenderers.

- 4.20 All the pages of the Technical / Financial Bid format shall be page numbered and all the relevant supporting documents as required must be enclosed along with tender.
- 4.21 The approved vendor has to quote considering the location of the cameras installation site and other accessories necessary for successful design, supply, installation, testing and commissioning of AI based forest fire warning system. The accessories should include but not limited to the indicated here. The accessories are indicative and it is intended to install the system in successful manner. Attached Annexure for Bill of quantity is an indicative list of items that may be used for successful installation. Please Note that the complete package of AI based forest fire warning system including towers and other items mentioned in BOQ may be increased or decreased. The payment will be made as per actual basis.
- 4.22 Payment Terms: 30% payment of the order value shall be released after the receipt of material in good condition at the installation site after inspection in phase wise manner. 60% of the order value shall be released after satisfactory installation / commissioning and handover of the equipment's in faultless working condition for period of 90 days from the date of satisfactory installation and submission of the test report. Balance 10% of the order value shall be released after 180 days after satisfactory installation and submission of the test report. No advance payment will be made under any circumstances.
- 4.23 The work should be carried out in close coordination with the authority, field staffs and with minimum disturbance to the wildlife and its habitat. No works shall be executed after sunset and before sunrise in the sanctuary area. The workers shall strictly abide the provision of the Wildlife Protection Act, 1972 or any relevant act time being in force. Any violation of the above provision will be viewed seriously may leads to rescindment of the entire contract.
- 4.24 The system should confirm highest standards of the engineering design and workmanship. The system should perform well without degradation for the service life of at least 10 years from the date of completion of Job.
- 4.25 It will be Bidder Firm's responsibility to enforce all safety measures/precautions required as per relevant codes for carrying out the work. The authority shall not be responsible for any mishap/injury/impairment caused to the workers.
- 4.26 Bidder/Firm has to clean all the debris left behind after work at the end of days. They shall be responsible for labour engaged for their code of conduct.
- 4.27 Laying fiber/ cabling/ pipe etc. is under this contract/ scope of work and route is subject to approval of the competent authority. All works involved at Site

grading, excavation in the soft soil, soft or hard murum, and back filling will be done with prior approval from the competent authority.

4.28 The work shall be completed within 90 days in all respect. Party has to submit the detailed time schedule for execution of the work after issue of Work Order.

4.29 Quotation should be valid till 180 days from the date of opening of financial bid.

4.30 **Termination for Default:** The 'Authority' may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Bidder, terminate the Contract in whole or in part: If the Bidder fails to deliver any or all of the Goods within the period(s) specified in the Contract, or within any extension thereof granted by the Purchaser; or If the Bidder fails to perform any other obligation(s) under the Contract. If the Bidder, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract. For the purpose of this clause: "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution. "fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution or a contract to the detriment of the borrower and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the borrower of the benefits of free and open competition. In the event the Purchaser terminates the Contract in whole or in part, the Purchaser may procure, upon such terms and in such manner as it deems appropriate, Goods or services similar to those undelivered, and the Bidder shall be liable to the Purchaser for any excess costs for such similar Goods or services. However, the Bidder shall continue the performance of the Contract to the extent not terminated. The contractor/bidder shall not display the photographs & content of the work and also will not take advantage through publicity of the work without written permission of the Authority. Non-Compliance to this may result in the blacklisted of firm. The incomplete and conditional tender will be rejected. Quoting unrealistic rates will also be treated as a disqualification.

4.31 **Force Majeure:** In no event shall either Party have any liability for failure to comply with this Agreement, if such failure results directly from the occurrence of any contingency beyond the reasonable control of the Party, including, without limitation, strike or other labour disturbance, riot, major power failure, war, natural calamities including but not limited to floods, earthquakes, fire, volcanic eruptions, epidemics, National Emergency, interference by any government or governmental agency, embargo, seizure, or enactment or abolition of any law, statute, ordinance, rule, or regulation (each a " Force Majeure Event"). In the event that either Party is unable to perform any of its obligations under this Agreement because of a Force Majeure Event, the Party who has been so affected shall as soon as may be, after coming to know of the Force Majeure Event, inform the other Party and shall take reasonable steps to resume performance as soon as may be after the cessation of the Force Majeure Event. If the period of non-performance due to a Force Majeure Event exceeds thirty (30) days, the Party whose ability to perform has been so affected may, by giving written notice, terminate this Agreement.

- 4.32 **Performance Security PBG (3% of the contract value)** should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the Bidder including warranty obligations. The same will be released only after expiration of the validity. The bank guarantee is to be given as per the format attached with this Tender. The successful contractor has to sign an agreement within 7 days from the date of issue of work order on the stamp paper of appropriate value as per format given herein.
- 4.33 The incomplete and conditional tenders will be rejected. Quoting of unrealistic rates will also be treated as disqualification.
- 4.34 Bidder shall not be permitted to withdraw his/her offer or modify the terms and conditions thereof after acceptance of tender. In case the Bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rate, the aforesaid amount of Earnest Money Deposit and Performance Guarantee will be forfeited by the 'Authority'. Besides this, the Bidder will also be liable to be debarred/blacklisted from participating in the tendering process of the 'Authority' in future and/or suitable penalty will be levied.
- 4.35 Normally no extensions of the scheduled delivery or completion dates should be granted except where events constituting force majeure, as provided in the contract, have occurred or the other circumstances demands for.
- 4.36 All the applicable taxes are to be paid by the Bidder/Firm. Price should be quoted accordingly. No price variation shall be allowed during the contract.
- 4.37 On receipt of intimation from the 'Authority' of the acceptance of his/their Tender, the successful Tenderer shall be bound to implement the contract and within 7 days thereof, the successful Tenderer shall sign an agreement and the Schedule of terms and conditions but the written acceptance by the 'Authority' of a tender will constitute a binding contract between the 'Authority' and the person so Tendering whether such formal agreement is or not subsequently executed.
- 4.38 Minimum one week Training Programme needs to be scheduled/arranged by the successful bidder, without any additional extra charges. The supplier shall provide training at desired places as fixed by the authority for personnel of user department on the operation, maintenance of the project "**Supply, Installation, Testing and Commissioning of Tower mounted AI camera for detection of Forest Fire & AI based surveillance on wild animal Movement with Real time Alert System**". Training manuals [5 copies] towards this should be prepared and handed over to the user department before starting of the training.
- 4.39 Guarantee/Warranty Duly signed and stamped certificate of at least 2 years comprehensive onsite warranty as per Annexure-B should be attached with the technical bid. Successful firm will be required to agree for payment of penalty for exceeding permissible downtime during Guarantee / Warranty period.
- 4.40 The material found defective upon opening by the supplier representative in presence of technical committee as constituted by the 'Authority' or not as per tendered specifications will be lifted back at the cost and risk of the supplier from the delivery site.

4.41 Arbitration

- a. In the event of failure to carry out the contractual obligations, with in the stipulated period or extended period and determination of the contract for any reason. Violation of the warranties etc. the 'Authority' shall have the right to carry out the unfinished obligation at the exclusive cost and risk of the bidder/firm, after due notice and the difference so accrued shall be recoverable from the bidder/firm.
- b. The provision of the Arbitration and conciliation Act, 1996 or as at relevant time and of rules framed there under and any statutory modifications thereof shall be deemed to apply and be incorporated in this agreement.
- c. Upon every or any such reference, the cost of any incidentals to the reference and award(s) respectively shall be at the reasonable discretion of the Arbitrators or in the event of their not agreeing, of the Umpire appointed the amount thereof or direct the same to be fixed as between solicitors and client or as between parties and shall be direct by whom and in what manner the same shall be borne and paid.
- d. Panel of arbitrators will be provided by the 'Authority' out of which the bidder will have to select one.
- e. The bidder shall have no objection if the officer who has dealt with the case at any stage is nominated as an arbitrator. Further, that one of the arbitrator's shall be Accounts Expert.
- f. In case of vacancy being caused due to resignation, death or incapacity of the arbitrator's to function as such, the same shall be provided in the aforesaid manner and the new arbitrator's shall proceed from the stage at which vacancy is caused.

4.42 All disputes shall be subject to the jurisdiction of the Court of Law at Baripada, Mayurbhanj, Odisha

5. KEY REQUIREMENTS OF THE BID

General requirement

1. Earnest Money Deposit:

- a. An EMD of the value @ ₹30,00,000/- (Rupees Thirty Lakh only) must be paid through Demand Draft/Cheque/Bank Guarantee in favour of the Deputy Director, Similipal South Wildlife Division, Bhanjpur, Baripada in any nationalized Bank payable at Baripada.
- b. The EMD should be submitted in the Technical Bid.
- c. The EMD of the unsuccessful bidders would be returned on the same day of the final selection of bidder.
- d. The EMD of successful bidder would be returned after submission of additional performance security.
- e. The bid / proposal submitted without EMD, mentioned above, will be summarily rejected.
- f. The EMD shall be forfeited:

- If Bid is withdrawn during the validity period or any extension agreed by the Bidder thereof.
 - If the Bid is varied or modified in a manner not acceptable to the Purchaser after opening of Bid during the validity period or any extension thereof.
 - If the Bidder tries to influence the evaluation process.
 - If the successful bidder fails to sign the contract or the performance guarantee is not submitted within the time specified
- g. The local MSE bidders are exempted from submission of EMD. However, they must furnish documentary evidence against the same.

2. Tender Paper Cost:

The participating bidders shall submit a non-refundable tender paper cost of **₹10,000/-** (Ten Thousand Only) though Demand Draft/Cheque in favour of Deputy Director, Similipal South Wildlife Division, Bhanjpur, Baripada in any nationalized Bank payable at Baripada.

3. Bidder Eligibility:

Any false and/or inadequate information can result in rejection of the tender. While deciding on the selection of contractors, emphasis will be given on the ability and competence of applicants to do good quality works in the specified time schedule and in close co-ordination with other agencies. Decision of the 'Authority' with regard to selection of contractors will be final. The 'Authority' is not bound to assign any reasons thereof. The following are the criteria:

- Experience:** The bidder shall have minimum 2-3 years of experience in the field of supply & installation of early warning system.
- Brand:** The bidder must be an OEM or registered dealer of the product they are intended to supply. In both of the cases the certificate to that effect to be furnished by the bidder.
- Clients:** The bidder shall have valid clients in India which it has served at least during last 3 years.
- Work History:** The bidder shall have served to any Government department or Forest Department in any States of India during last 3 years. The bidder shall have to produce an authenticate certificate to his effect during participation in the bidding or else the bidding will be summarily rejected.
- Registered office:** The bidder shall have registered office in India. The certificate to this effect should be submitted.
- Financial Stability:** The agency/vendor must have minimum turnover of at least Rupees Two crore every year in the last 3 years.






