2. Bidders Eligibility Criteria:

Bidders must fulfill the following eligibility criteria and submit documents mentioned in this tender document in support. The Bidders

- a) Must not be blacklisted by any department of Government of India/State Government.
- b) Should be registered with GST Department of Government of India/State Government.
- c) Should have registered office within India.

3. <u>Inspection of Items</u>:

The inspection of material can be done carefully by the prospective bidders or their representatives at office of the Deputy Director, Similipal South Wildlife Division, Bhanjpur, Baripada, Mayurbhanj, Odisha, 757002 between 22.08.25 to 01.09.25 (02.00 P.M) in any working days. Queries can be raised to the Administrative Officer at the time of inspection. No further clarification shall be entertained after the above inspection.

4. Tender paper Cost:

The participating bidder shall have to deposit the Tender paper cost of Rs.1,000/-(One Thousand Rupees) in shape of Demand Draft/Cheque in favour of the Deputy Director, Similipal South Wildlife Division, Baripada payable at Baripada in any Nationalized Bank alongwith the tender paper while submission of the bid. The tender paper cost is non-refundable. Any bid without the tender documents will summarily rejected and will not be allowed to participate in the further bid processing.

5. Earnest Money Deposit (EMD)/Bid security:

The bidder shall have to deposit Rs.10,000/-(Ten Thousand Rupees) in shape of Demand Draft drawn in favour of the Deputy Director, Similipal South Wildlife Division,

Baripada payable at Baripada in any Nationalized Bank. Parties not accompanied by the EMD shall be treated as invalid. Refund of EMD normally within 7 working days of auction sale. The bidders will not entitled to claim any interest if the refund of EMD is delay for any reason whatsoever. For successful bidders, EMD amount will be adjusted against payment of Bid Amount. For bidders not complying with term and conditions specified in the Auction Document, the EMD amount shall be forfeited.

6. Bid Validity Period:

Bids should remain valid for acceptance for a period of 15 days from the date of opening of the Bids. Bids with lesser validity period will be summarily rejected.

7. Financial Bid:

- a) The Financial bid shall be quoted in the Performa given at Annexure-II of this tender document.
- b) The financial bid of only those bidders shall be evaluated who fulfill the eligibility criteria.
- c) The bidder shall quote rate/amount for the whole lot.
- d) Any overwriting of /on amount quoted will render the bid to be invalid.
- e) GST or any other tax/duty, if applicable shall be borne by the bidder.
- f) The rate quoted shall be final.
- g) The successful bidder shall be evaluated on the basis of highest quoted price for the whole lot.

8. Submission of Bids:

- a) The Bid shall be legible, preferable typed/printed. All the pages of the Bid should be serially numbered and signed.
- b) The Bid prepared by the Bidders shall comprise of i) Details of Eligibility Criteria and ii) Financial Bid.
- c) Bid shall also include following documents:
 - (i) Submit and attach self- Attested copy of PAN CARD/ DRIVING LICENSE /AADHAR CARD/BANK PASSBOOK/etc. of the proprietor or firm.
 - (ii) Supporting documents alongwith address proof.

Sealed tenders superscripted "AUCTION SALE OF OLD AND UNSERVICEABLE BATTERIES, SOLAR PLATES AND INVERTERS" to Office of the Deputy Director, Similipal South Wildlife Division, Bhanjpur, Baripada, Mayurbhanj, Odisha, 757002 should be submitted within the dateline as prescribed in the tender notice.

Bids received after the closing date and time prescribed shall not be accepted under any circumstances. All the envelopes shall also indicate the name, address and phone number of the bidder enabling the Bid to be returned, if required.

09. Opening of Bids:

All bids containing Eligibility Criteria and Financial Bid shall be opened by the member of Auction Committee in presence of the Bidders or their authorized representatives. (only one person/representative from each bidder would be allowed to attend the bid opening tender).

10. Payment:

The successful bidder will have to pay the entire quoted/ offered amount in shape of cheque or Demand Draft in favour of the Deputy Director, Similipal South Wildlife Division, Baripada payable at Baripada in any Nationalized Bank within five working days after receipt of letter regarding award of contract, failing which the contract may be cancelled.

Submission Annexure-II at the time of receipt of the acceptance letter. The EMD payment of the successful bidder will be retained by this office till the completion of entire clean up/ lifting of obsolete goods by the bidder.

12. Lifting of Materials:

- (a) The successful bidder shall be required to lift all old, obsolete, un-repairable /used (redundant) batteries, Solar Plates and Inverters from the designated places to their premises on "AS IS WHERE IS BASIS" within five working days after depositing the full amount.
- (b) In case, the successful bidder deposits the full amount within a stipulated period but fails to lift the articles in the scheduled time, this Office shall not take responsibility for safe custody of the articles.
- (c) No damage shall be caused to the existing property of this Office or any other Offices in the premises while removing the materials from the site. Any loss / damage to the property of the Office or any other Offices in the premises or injury or personal accident suffered by any person due to negligence or action of the successful bidder or his authorized worker/supervisor will be borne by successful bidder and they will be indemnified.

13. Other Terms and Conditions:

(a) Goods/material will be removed under the supervision Administrative Officer. Materials will have to be removed within the time stipulated in acceptance letter. No extension of time will be given under ordinary convincing and satisfactory reasons for such delay given in writing by the bidder.

- (b) All operation i.e. loading, unloading and transportation to be incurred in course of lifting of items from designated places shall be borne by the successful bidder.
- c) In the event of failure of the successful Bidder to lift the items in the stipulated time frame, legal action may also be initiated. Further, the Bidder will be blacklisted for further business with this office and the Contract would be awarded to next Higher Bidder to lift the item (s) at H1 rate (s).
- d) This Office reserves the right to accept or reject any bid without assigning or communicating any reason thereof.
